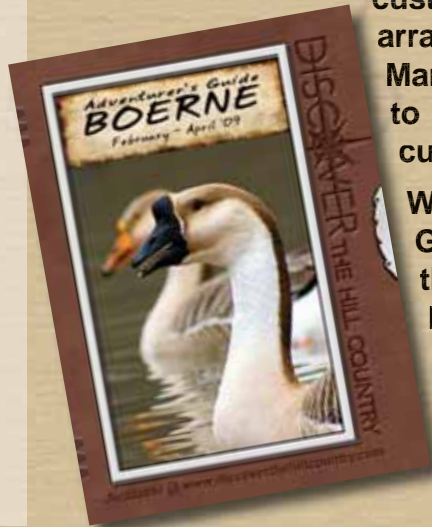
Our Members
